Introduction

Fat Man FX collects and processes your personal information in accordance with this privacy policy. This policy provides you with information regarding our obligations and your rights in compliance with the General Data Protection Regulation (GDPR).

Information That We Collect From You

Information that you provide to us directly might include personal information such as your name, email address and other personal details.

We may also collect non personal information that may identify you such as location, IP address, browser type, operating system and other details about the device you are using.

How we use your personal data

We use your personal data to provide our services or products to you. Where you have consented we may also use your information to send you promotional offers and marketing. You are free to withdraw this consent at any time.

We respect your privacy at all times. Your information will never be disclosed or shared with others without your consent, unless required to do so by law.

Your Rights

- Request that we delete your personal data in accordance with GDPR
